### THE ORDER IN COUNCIL

- AGMs that were due during emergency period or 30 days after it are suspended
- Electronic Notice of Board meetings *regardless of what bylaws say*
- Virtual Board Meetings even *without consent of all directors*
- All owner meetings and votes may be held electronically
- If a meeting's time/date/place is being changed to hold the meeting electronically, a new formal notice of meeting is not required (however, owners must still be notified)
- Owners may be served by electronic means, event without consent



### THE ORDER IN COUNCIL

- AGM Postponement
  - 1. By 90 or 120 days after the end of the emergency
  - 2. Only AGMs affected by the declaration of emergency
  - 3. You must hold
    - Requisitioned meetings
    - Turn-over meetings
    - Meetings if you've lost quorum





### HYPOTHETICAL DATES

- Emergency began on March 17, 2020
- Emergency ends (hypothetically) May 15, 2020
- 30-day period after end of emergency: June 14, 2020 (the "grace period")
- 90 days after end of emergency: August 13, 2020
- 120 days after end of emergency: **September 12, 2020**

### WHEN IS THE MEETING DUE?

#### AGM due during emergency (May 1, 2020)

• Due August 13, 2020 (90 days after emergency ends)

#### AGM due during grace period (May 31, 2020)

• Due September 12, 2020 (120 days after emergency ends)

#### AGM due after grace period (June 30, 2020)

Due June 30, 2020 (no change in deadline)

#### Requisitioned meetings (Requisition received on May 1, 2020)

• Due June 5, 2020 (regular deadline of 35 days still applies)

#### Turn-over meetings (Declarant no longer majority owner on May 1, 2020)

• Due June 12, 2020 (regular deadlines of 21 days to call and 21 days to hold meeting still apply)

#### Loss of quorum meetings (Board loses quorum on May 1, 2020)

• Due May 31, 2020 (regular deadline of 30 days still applies)




